Four options for band D payment had been circulated to Councillors prior to the meeting. Cllr Roderick-Jones proposed 'alternative 1' which is a zero increase on the Band D payment. Cllr Harris seconded. All agreed.

Discussions were held in relation to the community car scheme which had been previously in place. Cllr Timson was aware of some agencies that carry out similar work – he will find out more information and report back at the next meeting.
