Minutes of the Parish Council meeting held virtually on Wednesday, 10th March 2021 at 7.30pm

1. Public Participation

No members of the public were present.

2. County Councillor and District Councillor reports

a. County Councillor Spratt:

Reported that all schools in the area of Tibenham are free of Covid. Norfolk County Council (NCC) are spending money on upgrading the recycling at Diss and Wymondham – they are looking for a new recycling centre. NCC borrowed a further £12m bringing their total borrowing to £730m, with £30m a year interest. Long Stratton bypass may start at end of May. Council tax has gone up 4%.

b. District Councillor Easter:

Information received from Norfolk Association of Local Councils (NALC) that a new Flood Committee had been set up and a meeting had been held. A hotline will be set up, and an article will be in the EDP by Lord Dannatt regarding this new committee. A webinar will be held in March where Anglian Water, Fire Service and Water Resources will be present.

Census Day is 21st March 2021 this can be completed online, however, a paper version can be applied for. Diss and Roydon were set up as a testing centre for South African virus – no South African virus was found in 7,000 tested, however, 13 people tested positive for Covid 19. South Norfolk Covid 19 cases are decreasing. South Norfolk Council Tax is going up £5 per year. 60 new businesses have started up in Diss during lockdown.
