10. Pedestrial Safety in Pristow Green Lane.

It was agreed to purchase a new dog bin to be located at junction of Slough Lane with Pristow Green Lane.

12. Closure of footpath FP6 across Cargate Common.

13. Grit Bins.

It has been decided to place Grit Bins where Church Lane becomes The Street, and at the junction of Mill Lane with Diss Road. Support for these bins has been applied for to the Highways authority. 2 bins will now be purchased.

14. Electronic road sign for Pristow Green Lane.

It was felt the best solution may be a village sign, so warning drivers they are approaching a built up area. Chair to investigate pricing and supply.
